Through instant Crl. Transfer Application, the applicant/complainant seeks transfer of Sessions Case arisen out of Crime No.93/2015 registered at Police Station C-Section Kandhkot under section 365-B, 511, 506/II, PPC from the Court of learned 1st Additional Sessions Judge, Kandhkot to any other Court at District Kashmore having jurisdiction.
