Learned Additional Advocate General (A.A.G.) files comments/ statements on behalf of respondents No.4, 6, and 7, which are taken on record. Copies thereof have been supplied to the learned counsel for the petitioner. Mr. Nazir Hussain Chandio, Advocate, files vakalatnama on behalf of respondents No.8, 9, 11, 12, and 13, along with a statement supported by respective affidavits of respondents No.8, 9, 11, 12, and 13, which are also taken on record. Copies thereof have been supplied to the learned counsel for the petitioner.

Learned counsel for the petitioner contends that respondent No.8, who is the father of the petitioner and serving as a Police Constable, had divorced the petitioner's mother about ten years ago. He submits that the said respondent has been pressurizing the petitioner to marry the son of respondent No.11, and upon her refusal, respondents No.8 to 13 have been harassing and threatening her with dire consequences. It is further contended that respondent No.8, being a police official, is misusing his authority.

Conversely, learned counsel for respondents No.8, 9, 11, 12, and 13 has categorically denied all allegations and submits that the private respondents have neither caused any harassment to the petitioner nor do they intend to do so in future. He further submits that the private respondents shall not compel the petitioner to marry against her free will.

Learned Additional Advocate General submits that the official respondents are duty-bound to act strictly in accordance with law and shall provide protection to the petitioner, if and when required.

Learned counsel for the petitioner, after perusal of the comments /statements filed by both the official and private respondents, has expressed satisfaction and reiterates his request for protection to the petitioner.

In view of the above, this petition stands disposed of with the directions to the official respondents to act strictly in accordance with law and to ensure that no harm, harassment, or intimidation is caused to the petitioner or her mother, either by respondent No.8 or by any other person. The official respondents shall provide protection to the petitioner and her mother, as and when required. The respondent No.5, SSP Kamber-Shahdadkot, is directed to

look into the conduct of respondent No.8, who is alleged to be misusing his authority and issuing threats to the petitioner and her mother, and to take appropriate legal action if any misconduct is found.

Let a copy of this order be transmitted to the learned Additional Advocate General, Sindh, as well as to the official respondents concerned, for information and necessary compliance.
