The case of the petitioner is that he was an employee of BISE Larkana as Assistant Secretary BPS-17 and was transferred to BISE Shaheed Benazirabad vide Notification dated 24.12.2019. Petitioner joined his service there and he was promoted to the post of Deputy Secretary BPS-18 vide Notification dated 26.10.2025. The Petitioner is aggrieved by the Notification dated 05.05.2023 whereby he was repatriated to BISE Larkana by the Secretary to Government of Sindh, Universities & Boards Department, Karachi, where despite of his promotion as Deputy Secretary BPS-18 he worked as Assistant Secretary in BPS-17.

We have heard learned Counsel for the parties and perused the record.

After arguing the matter at some length the parties have consented that the impugned order dated 05.05.2023 may be set aside and the petitioner may be allowed to serve his duty at BISE Shaheed Benazirabad where the Board may conduct an inquiry into his promotion within a period of 02 months. This proposal is not opposed by learned Counsel for the petitioner. Accordingly, instant petition is **disposed of** and the Notification dated 05.05.2023 is hereby set aside. Petitioner shall join his duty at BISE Shaheed Benazirabad where he will be paid past and future salaries and that the Board shall be at liberty to determine the status of the promotion of the petitioner by providing him an opportunity of hearing strictly in accordance with law and

rules preferably within a period of two months’ time from today. The petitioner and the respondents shall be at liberty to avail the appropriate remedy in accordance with law.
