Mr. Abdul Rehman Bhutto, advocate for the applicant a/w the applicant.

1. Urgency is allowed.
2. Office objection be complied within three days.
3. Application for exemption is granted subject to all just exceptions.
4. Through this application, the applicant Liaquat Ali seeks pre-arrest bail in Crime No.142/2024, offence under Sections 337-A(i), F(i), F(v), 506/2, 147, 148, 149 P.P.C, registered at P.S. B-Section Kandhkot. His earlier bail application was declined by the learned II-Additional Sessions Judge, Kandhkot, vide order dated 17.12.2024.

Learned counsel for the applicant submits that the applicant is innocent and has falsely been implicated by the complainant in this case due to malafide intention and ulterior motives; that there is delay of 03 days in lodging of F.I.R without plausible explanation for such inordinate delay. He next submits that if the applicant will be arrested, he will be subjected to maltreatment, humiliation and disgracement at the hands of police. He, therefore, prays for grant of pre-arrest bail to the applicant/accused.

Be that as it may, without touching the merits and de-merits of the case, applicant Liaquat Ali is granted ad-interim pre-arrest bail subject to furnishing his solvent surety in the sum of Rs.50,000/- (Rupees fifty thousands) with P.R bond in the like amount to the satisfaction of the Additional Registrar of this Court. Let notice be issued to the D.P.G and complainant. To come on 03.03.2025 for confirmation or otherwise.
