

This protective bail granting order shall cease to operate on expiry of 05 days from today i.e. on 25.06.2022 or such earlier date when the applicant surrenders himself before the Court concerned, whichever is earlier. Meanwhile, operation of NBWs, if issued by the learned trial Court against the applicant, shall remain suspended during intervening period.
