Without touching merits of the case, applicant/accused Mitho alias Mithal Jatoi is admitted to protective bail in Crime No.34/2010, registered at Police Station Nasirabad, under Sections 17(3), Offences Against Property (Enforcement of Hudood) Ordinance, 1979 and 148, 149, PPC, for a period of 04 days from today subject to his furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court, thereby enabling the applicant to surrender before the Court concerned. Operation of NBWs issued by the trial Court against the applicant shall remain suspended for 04 days.

This order shall cease to operate on expiry of 04 days from today or when the applicant surrenders himself before the Court concerned, whichever is earlier.
