4. By this application, applicants Ghulam Akbar, Khadim Hussain, Muhammad Khan alias Muhammad and Shakeel Ahmed are seeking protective bail in Crime No. 73 of 2024 of P.S Market District Larkana for offence under Sections 114, 324, 337-A(i), 337-F(i), 34 PPC.

Learned counsel contended that applicants are innocent and they have been implicated falsely in the background of previous dispute which is also admitted in the FIR and the applicants are ready to join investigation but the concerned police is behind them to cause their arrest, hence they seek protection enabling them to avail the remedy available to them under the law.

Without touching merits and demerits of the case, applicants are granted protective bail for seven days subject to their furnishing solvent surety in the sum of Rs.50,000/= each and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. This order shall cease to operate after 7 days or on the day when the applicants appear before concerned Court, whichever is earlier.


