2. Applicant Faisal Karim S/o Abdul Karim Shaikh seeks protective bail in FIR bearing Crime No.03 of 2026 registered at Police Station Composite Circle, FIA, Hyderabad, for offences under Sections 406, 419, 420, 34 PPC.

Learned counsel contends that this is a false case registered against the applicant due to malafide intentions; that the applicant being law abiding citizen wishes to face trial; however, he apprehends that before reaching trial Court he might be arrested, humiliated and disgraced; therefore seeks legal protection.

Without dilating upon the merits of the case, the applicant is admitted to protective bail for a period of six (06) days subject to furnishing solvent surety in the sum of Rs.30,000/- (Rupees Thirty Thousand) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court.

This order shall cease to have its effect on expiry of five (06) days i.e. 30.03.2026 or when the applicant surrenders himself before the trial Court, whichever is earlier.

The bail application stands disposed of in above terms.
