1. Granted.
2. Through listed Application, applicant/surety submits that accused/applicant Abdul Salam Jaffer was granted protective bail for five days in Crime No.19/2023, under Sections 341, 337-H(2), PPC and 7, Anti-Terrorism Act, 1997, registered with P.S Agha Farm, District Shikarpur, on 24.10.2023. He next submits that in compliance of order dated 24.10.2023, applicant/surety Rafique Ahmed Jaffer stood surety on behalf of accused by depositing Special Savings Certificate for an amount of Rs.50,000/- before Accountant of this Court. After furnishing surety, applicant/ accused surrendered before the trial Court/Judge, Anti-Terrorism Court, Shikarpur, where he was admitted to interim pre-arrest bail vide order dated 27.10.2023. In support of his contention, he has placed certified copy of such order on record and submits that purpose of the bail bond as well as surety has been served; hence, surety documents deposited by him before this Court are no longer required and prays for its return.

Mr. Ali Anwar Kandhro, Addl. Prosecutor General, waives notice of listed application and has recorded no objection. Accordingly, instant application is allowed. Office is directed to return the surety documents, deposited by the applicant/surety before this Court, after proper verification, identification and as per rules.
