Without touching merits or demerits of the case, applicant Muhammad Yousif *alias* Mumtaz Chandio is admitted to transitive-cum-protective bail in Crime No.61/218, registered at PS Fareedabad, District Dadu, under Sections 324, 337-H(2), 148, 149, 504, 506/2, PPC, for seven (07) days subject to furnishing his solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand Only) and P.R. bond in the like amount to the satisfaction of Additional Registrar of this Court. Meanwhile, operation of NBWs issued against the applicant shall remain suspended for seven days.

This order shall cease to have its effect on 13.12.2023, or whenever the Applicant approaches / surrenders before the Court having jurisdiction, whichever is earlier.

This Criminal Bail Application stands disposed of in the above terms.

1. Urgency application is granted.
2. It appears that protective bail was granted to the applicant Muhammad Yousif @ Mumtaz son of Baig Muhammad Chandio, in Crime No.61/2018 of Police Station Fareedabad, Taluka Mehar, District Dadu, under sections 324, 337-H(ii), 148, 149, 504, 506/2, PPC by this Court vide order dated.07.12.2023 in the sum of Rs.50,000/- and P.R bond in the like amount. According to the report of Additional Registrar, surety was furnished by the applicant by producing Special Savings Certificate, issued by National Savings Centre-I, Larkana. After furnishing surety before this Court, the accused surrendered before the Court concerned vide CrI. Bail Appln. No.3078/2023, where he was granted pre arrest bail by way of order dated 13.12.2023. Hence purpose of surety bond stands served, therefore, submits that surety amount is no longer required by this Court; hence seeks its release/withdrawal.

Learned Addl. P.G after going through the record submits that the surety papers are no more required by this Court, therefore, he does not oppose the application for return of surety.

Accordingly, application for return of surety is allowed. Office is directed to return the surety documents viz. Special Savings Certificate to the surety after proper verification, identification and as per rules.
