O R D E R.

Muhammad Saleem Jessar-J.:-Through this application, applicant seeks his admission on pre arrest bail in Crime No.24 of 2023 of P.S Arija for offences under Sections 337-A(i), F(i), 147, 148, 149, 504, 506/2 PPC. Applicant filed pre arrest bail application before the Court of Sessions where he was granted interim pre arrest bail which was later on assigned to VIth Additional Sessions Judge, Larkana viz. Cr. Bail Appln. No. 1969 of 2023 where after hearing the parties the confirmation of bail to applicant was declined vide order dated 06.12.2023, hence this application has been maintained.

2. Since the facts of the prosecution case are already mentioned in the FIR as well as bail application and the order passed by trial Court, therefore, there is no need to reproduce the same.

3. At the very outset, learned counsel for the applicant submits that the co-accused Mukhtiar Ali, Nadeem Ali and Kareem Bux have been granted pre arrest bail by the Courts below whereas co-accused Zulfiqar and Manzoor Ali have also been granted post arrest bail by the trial Court, therefore, case of the applicant is at par with their case, hence he submits that he may also be granted bail. He further submits that the applicant as well as complainant have entered into compromise outside the Court.

4. Since the complainant and applicant have entered into compromise outside the Court, the offences with which the applicant stand charged are also compoundable and the co-accused have already been granted post arrest bail as well as pre arrest bail, therefore, in view of no objection by the complainant as well as Addl. P.G, this pre arrest bail application is allowed. The interim pre arrest bail granted to the applicant on 11.12.2023 is hereby confirmed on the same terms and conditions.
