Through this application, the applicant seeks his admission on pre arrest bail in Crime No.97 of 2023 of P.S Market under Section 489-F PPC.

As reported, case has been challaned which is now pending for trial before the Court of 3rd Judicial Magistrate Larkana and is fixed on 27.11.2023. The applicant filed Cr.Bail Appln. No.1237 of 2023 before the Court of Sessions which was assigned to 1st Additional Sessions Judge/MCTC, Larkana, who, after hearing the parties and considering the averments, declined the prayer so made in terms of his order dated 23.8.2023, hence this application has been maintained.

At the very outset, applicant present in person submits that he has settled down the differences with complainant outside the Court, therefore, he will move proper application before the trial Court for its disposal and prays that instant bail application may be granted.

Complainant Fahad Ali Katpar having CNIC No.434020579315-5 present in person admits that he has settled down the differences with the accused/applicant hence has no objection for grant of bail application. Learned Addl. P.G in view of above does not oppose the proposal.

Since the offence with which accused stand charged is compoundable, besides, the case is being tried by the Court of Judicial Magistrate. The complainant, who himself is victim, extended no objection, therefore, case against the applicant requires further enquiry.

Consequently instant pre arrest bail application is hereby allowed. The interim bail granted to him on 29.8.2023 is hereby confirmed on the same terms and conditions.

1. Urgency application is granted.

2. It appears that ad-interim bail was granted to the applicant Shafqat Hussain Kolachi in Crime No.79/2023 of Police Station Market Larkana under section 489-F, PPC by this Court vide order dated.29.08.2023 in the sum of Rs.100,000/- and P.R bond in the like amount. Subsequently, bail was confirmed on 16.11.2023. Learned counsel has placed on record true copy of order dated.27.11.2023, passed by Civil Judge & J.M-III, Larkana, whereby the accused has been acquitted of the charge.

According to the report of Additional Registrar, surety was furnished by the applicant by producing Special Savings Certificate, issued by National Savings Centre-II, Larkana.

Learned Addl. P.G after going through the record submits that the surety papers are no more required by this Court, therefore, he does not oppose the application for return of surety.

Accordingly, application for return of surety is allowed. Office is directed to return the surety documents viz. Special Savings Certificate to the surety after proper verification, identification and as per rules.
