Mr. Ali Nawaz Ghangro, advocate for the applicants a/w the applicants.

1. Urgency is granted.
2. Deferred for the time being.
3. Exemption is granted subject to all just exceptions.
4. Through this application, the applicants Mehar son of Hashim Depar and Juman son of Shah Nawaz Depar seek protective pre-arrest bail in Crime No.186/2010 of P.S. Waleed Larkana, under Sections 302,34 P.P.C, which was tried by the court of Additional Sessions Judge-I, Kambar, vide Sessions Case No.70/2011, re: State V/S Mehar and others.

Learned counsel for the applicant submits that due to tribal dispute, the applicants went undergone and were not aware of the pendency of the instant case and now their disputes have been settled down upon the interventions of their elders. They being law abiding citizens have attempted to surrender before trial court but the trial court had already kept their case against them on dormant file by issuing N.B.Ws against them, they, therefore, came before this court for appropriate relief. The point so raised requires consideration.

Accordingly, instant application is hereby allowed. The applicants Mehar Depar and Juman Depar are hereby granted protective pre-arrest bail in Crime No.186/2010 of P.S. Waleed, Larkana, under Sections 302,34 P.P.C for seven days from the date of this order subject to their furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousands) each and P.R bond in the like amount to the satisfaction of the Additional Registrar of this court.

This order shall cease to have its effect on expiry of period of seven days or on the date when the applicants surrenders themselves before the concerned court whichever is earlier. The bail application stands disposed of in the above terms.

Applicant/surety Bashir Ahmed, had stood surety for accused Mehar and Juman, who were granted protective bail by this Court for a period of seven days in FIR No.186/2010 registered at Police Waleed, Larkana, for offences under section 302, 34, PPC enabled them to surrender themselves before the concerned Court, vide order dated 01.02.2019.

Applicant/surety mainly contends that the aforesaid applicants/accused, after grant of protective bail surrendered themselves before the learned II-Additional Sessions Judge, Larkana, on 06.02.2019 i.e. within stipulated period, wherefrom they were admitted to ad-interim pre arrest bail and that the purpose of surety has been served. He, therefore, prays that Defence Saving Certificates furnished as surety may be returned to the applicant. Learned A.P.G endorsing the contention raised by the applicant/surety has recorded no objection.

In view of the above, the Defence Saving Certificates No.JB-283667 & JB-283668 issued by National Saving Centre, Ratodero having been furnished as surety by the applicant are ordered to be returned to the applicant/surety on proper verification, attestation and identification. The application stands disposed of.
