4. Applicants 1. Ali Haider, 2. Gul Hassan Khan alias Munawar Ali, 3. Mehrab Khan, 4. Suhrab Khan, 5. Sher Dil and 6. Samar Khan, all by caste Dahani, seek protective bail in Crime No.54/2011 of Police Station Ratodero, District Larkana, registered under Sections 324, 353, 148, 149, PPC.

Learned Counsel for the applicants submits that the applicants were unaware about registration of this false case against them by the police. He further submits that the applicants are unable to appear before the concerned Court/trial Court for seeking remedy in shape of pre-arrest bail as required by Section 498, 498-A, Cr.P.C due to issuance of NBWs by the trial Court. He submits that in case the applicants are arrested, they will be subjected to maltreatment and humiliation at the hands of police, besides, their dignity, honour and prestige will be damaged/spoiled.

Without touching merits or demerits of the case, applicants are admitted to protective pre-arrest bail for 08 days from today, subject to their furnishing solvent surety in the sum of Rs.30,000/- each and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. Operation of NBWs issued by the trial Court against the applicant shall also remain suspended for the said period of 08 days.

This order shall cease to operate on expiry of 08 days from today i.e. on 11.02.2019 or such earlier date when the applicants surrender before the Court concerned, whichever is earlier.

Bail application stands disposed of in above terms along with all listed applications.

Applicant/surety Allah Dinor, had stood surety for accused Ali Haider, Gul Hassan Khan alias Munwar Ali, Mehrab Khan, Suhrab Khan, Sher Dil and Samar Khan, who were granted protective bail by this Court for a period of eight days in FIR No.54/2011 registered at Police Station Ratodero, District Larkana for offences under section 324, 353, 148, 149, PPC enabled them to surrender themselves before the concerned Court, vide order dated 04.02.2019.

Applicant/surety mainly contends that the aforesaid applicants/accused, after grant of protective bail surrendered themselves before the learned Sessions Judge-, Larkana, on 08.02.2019, wherefrom they were admitted to ad-interim pre arrest bail vide order dated 08.02.2019 and that the purpose of surety has been served. He, therefore, prays that Special Saving Certificates furnished as surety may be returned to the applicant. Learned D.P.G endorsing the contention raised by the applicant/surety has recorded no objection.

In view of the above, the Special Saving Certificate No.HE-626537 to No.HE-626540 issued by National Saving Center-I, Larkana having been furnished as surety by the applicant are ordered to be returned to the applicant/surety on proper verification, attestation and identification.
