4. Through this application, applicant Nazir Muhammad alias Nazir Ahmed seeks protective bail in Crime No.02/2019, registered with A.C.E, P.S Kashmore @ Kandhkot, for offences punishable under Sections 161, 420 P.P.C read with Section 5 (2) of the Prevention of Corruption Act-II of 1947.

Learned counsel for applicant contends that applicant intend to surrender before learned trial Court, but because of issuance of NBWs against him by the learned trial Court, he is apprehending his arrest before hearing of his application for pre-arrest bail.

Without touching merits and de-merits of the case, the applicant is granted protective bail for a period of seven (07) days commencing from today upon his furnishing solvent surety in the sum of Rs.30,000/- (Thirty thousand rupees) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court, enabling him to approach concerned Court. This order shall cease to have effect on expiry of aforesaid period of seven days. Operation of NBWs issued against applicant shall remain suspended during intervening period. The application stands disposed of.

2. Applicant Dost Mohammad Mazari has filed listed application for return of surety papers viz. Special Savings Certificate No. HE-626839 of Rs. 50,000/-, deposited by him before this Court, on the ground that after grant of protective bail for seven days by this Court vide order dated 25.02.2019, accused Nazeer Ahmed Golo appeared before the trial Court i.e. Special Judge, Anti-Corruption (Provincial), Larkana within time, where he was admitted to pre-arrest bail in Crime No. 02/2019 of PS ACE, Kashmore at Kandhkot, under Sections 161, 420, PPC read with Section 5(2) Act-II of 1947. Subsequently, accused Nazeer Ahmed Golo has been acquitted by the learned trial Court vide judgment dated 23.12.2019.

Certified of judgment has been placed on record.

The contention of the applicant/surety is borne out from the record and report furnished by Accountant of this Court also confirms the above position. Learned DPG after going through the file has recorded no objection.
