Fifty thousand only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court, thereby enabling him to surrender before the Court concerned for appropriate relief.

This protective bail granting order shall cease to operate on expiry of five days from today i.e. on 22.03.2019 or such earlier date when the applicant surrenders before the Court concerned, whichever is earlier.

Bail application stands disposed of.


2. Applicant/surety Sahib Ali, had stood surety for accused

Muhammad Hassan, who was granted protective bail by this Court for a period of five days in FIR No.16/2019 registered at Police Station ACE Kamber Shahdadkot, District Kamber Shahdadkot, for offences under section 409, 468, 477-A, PPC R/w Section 5(2) Act-II, 1947 enabled him to surrender himself before the concerned Court, vide order dated 18.03.2019.

Applicant/surety mainly contends that the aforesaid applicant/accused, after grant of protective bail surrendered himself before the learned Special Judge Anti-Corruption, (Provincial), Larkana, on 21.03.2019 i.e. within stipulated period, wherefrom he was admitted to ad-interim pre arrest bail and that the purpose of surety has been served. He, therefore, prays that Special Savings Certificate furnished as surety may be returned to the applicant. Learned D.P.G endorsing the contention raised by the applicant/surety has recorded no objection.

The applicant/surety has placed on record the letter issued by the Reader of the Special Judge, Anti-Corruption, (Provincial), Larkana instead of the order signed by the Special Judge, Anti-Corruption, (Provincial) Larkana, wherein the applicant/accused has surrendered and obtained the ad-interim pre arrest bail. In these circumstances, instant application is allowed and the office is directed

to return the Special Savings Certificate No. HE-626909 issued by National Savings Centre Larkana, having been furnished as surety by the applicant subject to verification of the letter No.524 dated 21.03.2019 issued by the Reader of Special Judge Anti-Corruption (Provincial), Larkana, after proper verification and identification. The application stands disposed of.
