4. Through this application, applicant Abdul Jabbar Wagan seeks protective bail in F.I.R No.14/2019, registered with ACE P.S Kamber-Shahdadkot @ Kamber, for offences punishable under Sections 409, 477-A P.P.C read with Section 5 (2) of Prevention of Corruption Act-II of 1947.

At very outset learned counsel submits that, earlier in time the applicant was granted protective bail by this Court vide Order dated 22.02.2019 for a period of five days subject to furnishing solvent surety in the sum of Rs.30,000/- and P.R bond in the like amount in connection with Crl. Bail Appln. No. S- 110 of 2019, and the applicant furnished the required surety before this Court, but due to some unavoidable circumstances, he could not appear before the concerned Court and the time period of five days has expired, as such learned counsel prays for extension of time of protective bail for further five days on same terms, conditions and same surety.

In view of above, the applicant is granted protective bail for further period of five (05) days commencing from today on same terms, conditions and same surety furnished in earlier bail application i.e. Crl. Bail Appln. No. S- 110 of 2019, but subject to execution of fresh <sup>bond &</sup> affidavit by the surety. The application stands disposed of.

Through instant application, applicant/ surety Rasheed Ahmed seeks return of surety documents on the plea that applicant stood surety for accused Abdul Jabbar Wagan, who was granted protective bail for five days in Crime No. 14/2019 of ACE P.S Kamber-Shahdadkot @ Kamber, vide Order dated 22.2.2019 passed in Crl. Bail Appln. No. S- 116/2019, and it was extended for further five days vide order dated 28.2.2019 passed in Crl. Bail Appln. No. S- 122/2019, thereafter, the accused surrendered before the concerned Court and has been admitted to interim pre-arrest bail vide Order dated 01.03.2019 passed by learned Special Judge Anti-corruption (Provincial), Larkana. Certified copy of the same order has been placed on record.

Learned D.P.G concedes for grant of application.

Since protective bail was granted for specific period and such period does not exist now and the accused has already surrendered before the concerned Court, thus instant application is allowed. Office is directed to return surety papers to the applicant after proper verification and identification against a valid receipt.
