4 & 5. Applicants Ghulam Mustafa and Nadir seek protective bail in Crime No.25/2013 of P.S Civil Line (District Larkana), for offences punishable under Sections 302, 148, 149 P.P.C.

Learned counsel for the applicants contends that applicants have been shown absconders in the case; the said case was challaned by the police on 01.04.2013 and finally it was accepted on 26.4.2013; later on the case was instituted as Sessions case No.211/2013, Re; State v. Farooque and others, where co-accused Farooq and Arbab were tried and subsequently acquitted from the charge by means of judgment dated 22.8.2017 delivered by V-Additional Sessions Judge, Larkano. Learned counsel submits that the applicants being ignorant of law were unaware about pendency of the case against them and as soon as they learnt about pendency of case they have voluntarily rushed to this Court for protection as they intend to surrender themselves before the trial Court. Learned counsel prays for suspension of NBW and proclamations issued against the applicants.

Be that as it may, without touching merits and de-merits of the case, the applicants are granted protective bail for a period of seven (07) 1

days commencing from today on their furnishing solvent surety in the sum of Rs.50,000/- (Fifty thousand rupees) each and P.R bonds in the like amount to the satisfaction of Additional Registrar of this Court. This order shall cease to have effect on expiry of aforesaid period of seven days or on the day when the applicants surrender before the concerned Court, whichever is earlier. Meantime, operation of NBWs/ Proclamations issued against the applicants is suspended for said period.

The application stands disposed of.
