1. Urgency granted.
2. Office objection overruled.
3. Exemption application is disposed of.
4. It is, *inter alia*, contended by the learned counsel for the applicant that applicant Sultan Ahmed son of Nizamuddin Soomro is innocent and he has been falsely implicated in the FIR bearing Crime No.15 of 2019 registered at Police Station ACE Kamber Shahdadkot for offence punishable under sections 409, 477-A, 34, PPC R/w Section 5(2) Act-II of 1947 by the complainant/ACE Police due to enmity; and that the applicant apprehends his arrest with ulterior motive in approaching the concerned Court. He therefore, prays that the protective bail may be granted to the applicant to enable him to surrender himself before the concerned Court.

Be that as it may, without touching the merits of the case, applicant is admitted to protective bail for a period of (07) seven days subject to his furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. This order shall cease to have effect on expiry of seven days from today i.e. on 20.02.2019 or on the applicant's surrendering before the concerned Court, whichever is earlier.

Bail Application stands disposed of.

Applicant/surety Noor Muhammad, had stood surety for accused Sultan Ahmed Soomro, who was granted protective bail by this Court for a period of seven days in FIR No.15/2019 registered at Police Station ACE Kamber Shahdadkot, for offences under section 409, 477-A, 34, PPC R/w 5(2), Act II, 1947 enabled him to surrender himself before the Court of Special Judge, Anti-Corruption (Provincial), Larkana, vide order dated 14.02.2019.

Applicant/surety mainly contends that the aforesaid applicant/accused, after grant of protective bail surrendered himself before the learned Court of Special Judge, Anti-Corruption (Provincial), Larkana, on 15.02.2019 i.e. within stipulated period and that the purpose of surety has been served. He, therefore, prays that Defence Saving Certificates furnished as surety may be returned to the applicant. Learned D.P.G endorsing the contention raised by the applicant/surety has recorded no objection.

In view of the above, the Defence Saving Certificate No.JB-435701 having been furnished as surety by the applicant is ordered to be returned to the applicant/surety on proper verification, attestation and identification. The application stands disposed of.
