1. Urgency application granted.
2. Over-ruled.
3. Exemption allowed subject to all just exceptions.

Through this application, applicants Israr Ahmed, Sanaullah Babbar, Budhar Mal, Ghulam Sarwar, Muhammad Zakir, Lal Chand Mal, Kamran Ali, Imam Bux and Abdul Ghani seek protective bail in Crime No. GO-01/2018, registered with ACE P.S Jacobabad, for offences punishable under Sections 161, 205, 419, 420, 34 P.P.C read with Section 5 (2) of the Prevention of Corruption Act-II of 1947.

Learned counsel for applicants contends that applicants intend to surrender before learned trial Court, but because of issuance of NBWs against them by the learned trial Court, they are apprehending their arrest before hearing of their application for pre arrest bail.

Without touching merits and de-merits of the case, the applicants are granted protective bail for a period of seven (07) days commencing from today upon their furnishing solvent surety in the sum of Rs.30,000/- (Thirty thousand rupees) *each* and P.R bonds in the like amount to the satisfaction of Additional Registrar of this Court, enabling them to approach concerned Court. This order shall cease to have effect on expiry of aforesaid period of seven days. Operation of NBWs issued against applicants shall remain suspended during intervening period. The application stands disposed of.

As per report of Accountant, one Gul Mir son of Manjhan Khan by caste Babar appeared and furnished required surety which was accepted by Additional Registrar of this Court.

Learned counsel for the applicant/surety submits that after getting protective bail from this Court the applicants/accused surrendered before the learned trial Court where they were admitted to ad-interim pre-arrest bail vide order dated 26.02.2019. He submits that the purpose of protective bail has been achieved and now he prays for release of his surety. Learned D.P.G has recorded no objection to the grant of this application.

In view of the above, instant application is allowed. Office is directed to return the surety papers to the applicant after proper verification and identification as per rules.
