Without touching merits or demerits of the case, applicant Bakhar Phull alias Bakhar son of Allah Warayo Phull is admitted to protective bail for seven (07) days from today in Crime No.123/1993 of Police Station B-Section, Larkana, registered under Sections 324, 114, PPC & 13 DAO, subject to his furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court, only to enable the applicant to surrender before the Court concerned for appropriate relief. Meanwhile, operation of NBWs, if any, issued against the applicant by the trial Court shall remain suspended for said 07 days.

This order shall cease to operate on expiry of 07 days from today i.e. on 20.02.2019 or such earlier date when the applicant surrenders before the Court concerned, whichever is earlier.

Bail application stands disposed of in above terms along with all pending application(s).
