1. Urgency granted.
2. Applicant/surety Abdul Karim, had stood surety for accused Waheedullah Chandio, who was granted protective bail by this Court for a period of seven days in FIR No.06/2019 registered at Police Station Ahmedpur, District Khairpur, for offences under section 365-B, 34, PPC enabled him to surrender himself before the concerned Court, vide order dated 07.02.2019.

Applicant/surety mainly contends that the aforesaid applicant/accused, after grant of protective bail surrendered himself before the learned Additional Sessions Judge-II, Khairpur, wherefrom he was admitted to ad-interim pre arrest bail and subsequently that order was confirmed vide order dated 23.02.2019 and that the purpose of surety has been served. He, therefore, prays that Special Savings certificate furnished as surety may be returned to the applicant. Learned A.P.G endorsing the contention raised by the applicant/surety has recorded no objection.

In view of the above, the Special Savings Certificate No. HE-626562 having been furnished as surety by the applicant is ordered to be returned to the applicant/surety on proper verification, attestation and identification. The application stands disposed of.
