Mr. Abdul Rehman A. Bhutto, advocate for the applicant, along with applicant.

1. Granted.
2. Overruled.
3. Granted subject to all just exceptions.

Learned Counsel submits that the name of applicant does not find place in the FIR; however, he was implicated on the basis of statement of co-accused Mohammad Ishaque alleging that he used to sell and transport the narcotic contraband owned by the present applicant. He further submits that co-accused Mohammad Ishaque stands convicted by the trial Court by means of judgment dated 28.1.20108, whereas case against the applicant was ordered to be kept on dormant file. He further submits that the applicant had no knowledge about registration of this false case against him and as and when he learnt about it, he attempted to appear before the trial Court, but due to issuance of NBWs the concerned police have cordoned off the premises of trial Court and have made his entry there impossible, hence he could not do so.

Be that as it may, without touching merits or demerits of the case, applicant Dilmurad son of Allah Bux Lashari is admitted to protective pre-arrest bail for ten (10) days from today in Crime No. 131/2007 of Police Station Sadar Dera Murad Jamali (Balochistan), registered under Sections 9(c) of CNS Act, 1997, subject to his furnishing solvent surety in the sum of Rs.30,000/- and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court, thereby enabling him to surrender before the Court concerned for the appropriate relief. Meanwhile, operation of NBWs, if any, issued by the



trial Court against the applicant shall also remain suspended for such period of 10 days.

This protective bail granting order shall cease to operate on expiry of 10 days from today i.e. on 21.03.2019 or such earlier date when the applicant surrenders before the Court concerned, whichever is earlier.

Bail application stands disposed of in above terms along with all pending application(s).
