3. Exemption allowed subject to all just exceptions.
4. The applicants/ accused have been booked in F.I.R No.147/2017 registered with P.S K.N. Shah (Dadu) for offence under Sections 302, 201 P.P.C. Learned counsel submits that the applicants have been implicated by the complainant falsely and F.I.R in question has been filed upon directions of Ex-Official/Justice of Peace and there is series of litigation between the parties. He next argued that applicants are elders of their community; they apprehend their malafide arrest at the hands of police. He submits that applicants being good citizens have voluntarily surrendered before this Court; aims to join Court proceedings and intend to surrender before the Court concerned for having appropriate relief but the police concerned in collusion with complainant party have cordoned all the ways and paths leading towards the Court; such action of the police at the behest of complainant party have constrained the applicants to get protection from this Court.

Be that as it may, without touching merits and demerits of the case, the applicants are granted protective pre arrest bail for ten (10) days commencing from today subject to their furnishing solvent surety in the sum of Rs.50,000/- (Fifty thousand rupees) each and P.R bonds in the like amount to the satisfaction of Additional Registrar of this Court. This order shall cease to have effect on expiry of aforesaid period of ten days or on the date when applicants surrender before the Court concerned, whichever is earlier. The application stands disposed of.
