4. & 5. Through this application, the applicant Saifullah @ Mir seeks protective bail in crime No.25/2013, registered under Sections 302,148 and 149 P.P.C at P.S. Civil Lines Larkana

Learned counsel for the applicant contents that applicant has been shown absconder in the case; the said case was challaned by the police on 01.04.2013 and finally it was accepted on 26.04.2013; later on the case was instituted as Sessions Case No.211/2013, Re: State V. Farooque and others. where co-accused Farooq and Arbab were tried and subsequently acquitted from the charge by means of judgment dated 22.08.2017 delivered by V- Additional Sessions Judge, Larkana. He further submit that the applicant being ignorant of law was unaware about pendency of the case against him as soon as he learnt about pendency of case he has voluntarily rushed to this court for protection as he intends to surrender himself before the court concerned for appropriate relief.

Be that as it may, without dilating upon the merits of the case, applicant Saifullah @ Mir Magsi is admitted to protective bail for seven days from the

date of this order subject to his furnishing a solvent surety in the sum of Rs.50,000/- and P.R bond in the like amount to the satisfaction of the Incharge Additional Registrar of this court.

This order shall cease to have its effect on expiry of period of seven days i.e. on 08.11.2017 or on the date when the applicant surrenders himself before the concerned court whichever is earlier.

The bail application stands disposed of in the above terms.
