3&4. Through these proceedings, petitioner has impugned the notice dated.08.4.2013 issued by Respondent No.3, whereby petitioner is directed to pay electricity dues Rs.12,21,195/- within a month.

Learned counsel for the petitioner contended that petitioner is unaware of outstanding dues; neither description and complete details / break up of bill is provided to the petitioner nor find place in the impugned letter.

Learned Deputy Attorney General present in Court, waives notice and submits that official respondents will act strictly in accordance with law, however, he very candidly conceded that neither description of amount which is subject matter of impugned letter has been provided to the petitioner nor detail thereof find place.

In view of above, we dispose of instant petition with directions to the official respondents, to provide complete description, breakup in respect of outstanding amount to the petitioner within two weeks and thereafter, petitioner shall appear before the concerned authorities within a week, till then no coercive action shall be taken against the petitioner.
