Through this Criminal Miscellaneous Application, the applicant namely Mst Zainab wife of Abu Bakar has impugned the order dated 29.05.2025 passed by the learned Additional Sessions Judge-I/Ex-Officio Justice of the Peace, Sanghar in Crl. M.A No.981/2025, wherein the application of the applicant was dismissed. Being aggrieved from the order of court below the applicant has filed instant application.

Per learned counsel in fact the applicant Mst Zainab intend to lodge the FIR against her husband and her mother in law on the ground that proposed accused persons committed rape with her and requested that the SHO concerned may be directed to lodge the FIR of the applicant against the proposed accused persons.

From careful perusal of record, it reveals that on 17.07.2023, the proposed accused No.1 namely Abu Bakar Shar, husband of the applicant, got registered an FIR, at P.S Perumal, bearing Crime No.56/2023, U/Ss 496, and 215 PPC, against Saddam, Veendal alias Veenjhal Shar, and Fida alias Abdal (proposed accused Nos. 5 to 7), regarding rape with her wife (applicant). On 17.06.2023, and for receiving an amount of Rs.50,000/- from him for return of his wife (applicant). Such case was challaned, and is pending adjudication before learned Additional Sessions Judge, Khipro. The record further shows that the applicant, and proposed accused No.5 namely Saddam Shar, filed C.P No.D-590 of 2024, against proposed accused No.1

namely Abu Bakar and others, before the Circuit Court, Hyderabad, where in Investigating Officer SIP Sultan Ahmed P.S Peeromal District Sanghar of the subject FIR is directed to record 161 Cr.P.C statement of petitioner No.1 Mst. Zainab, and submit the same before the concerned Judicial Magistrate for passing appropriate orders.

In view of the above the applicant has failed to made out the case for the registration of FIR and I have perused the impugned order, which does not suffer illegality or material irregularity in order passed by the learned Additional Sessions Judge-I/Ex-Officio Justice of the Peace, Sanghar, hence instant Criminal Miscellaneous Application is hereby dismissed in Limine.
