Mr. Muhammad Sharif Solangi, Assistant A.G. Sindh along with Sanaullah Abro Mukhtiarkar Khipro on behalf of D.C. Sanghar.

Petitioners are differently abled persons. They filed this constitutional petition under Article 199 of Islamic Republic of Pakistan, 1973 seeking the following relief: -

- a. That this Honourable Court may graciously be pleased to issue directions to the official Respondents to comply with the orders dated 20.12.2022 (passed in Civil Petitioners No.966-K to 971-K of 2022) including order dated 09.09.2024 (passed on contempt application filed by the petitioners) by making appointment of remaining differently abled persons in view of aforesaid orders, who are depriving of their legal and legitimate right of appointment.
- b. That Article 189 of the constitution (binding nature of Supreme Court decisions) refers in the manner that decision of Supreme Court of Pakistan shall be binding on all other courts in Pakistan. That the Honourable Supreme court is the highest court in Pakistan and its decisions are binding on all lower Court, including High Courts and subordinates Courts.

- c. That the remaining petitioners are depriving of their legal and legitimate right despite of orders of Honourable Supreme Court of Pakistan since 2022, hence the Respondents may be directed to conduct DRCs forthwith so that remaining petitioners be accommodated accordingly.
- d. That Section 11 (12) of Sindh Empowerment of "Persons with Disabilities" Act, 2018 relates to appointment of differently abled persons in all Government departments, including semi-government, corporations, all other institutions worked under Government of Sindh without delay or otherwise.
- e. To direct the respondents to implement 5% quota in all Government Departments as well as Corporate "Sectors as per Section 11 (12) of Sindh Empowerment of "Persons with Disabilities" Act, 2018, without fail.
- f. Any other order may deem fit and proper may kindly be passed in favour of the petitioners as the petitioners are totally depend upon the mercy of this court.
- g. Cost of the petition.

Today learned A.A.G. Sindh has filed statement asserting that as and when positions occur, the recruitment process would be carried out for necessary compliance of the directions of this court and accordingly the petitioner will be accommodated.

Learned counsel for the petitioners is satisfied with the above statement and seeks disposal of this petition in terms of the statement made by Deputy Commissioner filed today.

The petition stands **disposed of** in the above terms.
