Muhammad Ali Mazhar, J: The Respondents published an advertisement for different positions. The Petitioner applied for Junior Assistant-II for which besides requirement of F.A, F.Sc, I.Com and D.Com (First Division), six months Automation Course was also necessary. Learned counsel for the petitioner referred to the copy of application of the Petitioner available at page No.13 which shows that he was in BBA at the time of applying for job, however, three papers were left to be cleared, while in computer skills he mentioned Ms Office (Advance) Certified Course from SBTE, CIT Certified Course from SBTE, Internet (Browsing,

E-mailing & Chatting etc) and Typing in English and Urdu. Since one of the requirements was six months Automation Course, therefore, the learned counsel pointed out the Certificate issued by Expert Inn Institute for Office Automation Course attended by the petitioner from 1st February, 2012 to 30th July, 2012. He submits that despite fulfilling all the requirements, the petitioner was not allowed to join.

The Counter Affidavit of the respondents is available on record in which it is stated that at the time of filing application, the petitioner submitted only four months Certificate issued by Roshi Computer Institute and after considerable time another Certificate issued by Expert Inn Institute was submitted for six months Course. The last Certificate was sent to the Secretary Sindh Board of Technical Education for verification purpose but on 21.01.2014 Sindh Board of Technical Education responded that the said Computer Institution is not registered with the Sindh Board of Technical Education. Learned counsel for the respondents argued that the recruitment process was started in the year, 2013 and now it has been completed and all vacant positions have been filled. While the learned counsel for the petitioner argued that still some vacancies have not been filled and the process has been stopped under the orders of the Chairman Atomic Energy but he has not produced anything in writing to substantiate this contention. Learned counsel for Respondents agrees that if any suitable vacant position is found available, the case of the petitioner will be considered on merits

for which he has to approach to the concerned department. Learned counsel for the Petitioner agrees to this proposal. The petitioner shall approach alongwith all his credentials to the concerned department and if any suitable position is found vacant, commensurate to the qualification of the petitioner, then he will be considered for the job in accordance with department Rules and Regulations. The petition is disposed of.
