3. The petitioners had applied for pre-arrest bail on the basis of call-up notice issued on 25th July, 2016. This court granted interim bail on 20.09.2016 subject to furnishing solvent surety in the sum of Rs.500,000/- each with PR bonds in the like amount with further direction to deposit original passports with Nazir of this court.

Brief facts of the case are that the petitioner No.1 is father of the petitioner No.2 who purchased land in the month of December, 2004 in the name of his daughter Ms. Saba (petitioner No.2) and land was also mutated in the name of petitioner No.2 in the record of rights. Copies of sale deed and Form VII-B are available at Page-13 to 29. Call-up notice was issued to the petitioner No.2 for the purpose of recording her statement in connection with investigation against Asadullah Solangi, Ex-Mukhtiarkar Thano Bola Khan and others and she was asked to appear for recording statement alongwith Deed of Conveyance dated 30.12.2004 and other relevant ownership documents in respect of agricultural land measuring 110.02 acres situated at Deh Babur Bund Taluka Thano Bola Khan, district Jamshoro and consideration paid to the seller.

Learned ADPG, NAB and Investigating Officer, NAB submit that matter is at investigation stage and the petitioners appeared and produced all relevant documentary evidence and they also cooperated in investigation. Investigating Officer further submits that matter is under process and no reference has been filed so far and it is also to be decided whether present petitioners will be implicated as accused or not. Since passports are deposited with Nazir of this court, therefore, the petitioners have applied for permission to travel to Frankfurt due to some business affairs. Learned counsel submits that now petitioner No.1 wants to travel only, therefore, he requests that directions may be issued to return back his passport for one time visit so that he may travel and return to Pakistan on or before 20.01.2017. Learned ADPG, NAB and Investigating Officer, both, have no objection to this request.

Nazir of this court is directed to return passport of the petitioner No.1 who will return back to Pakistan on or before 20.01.2017 and after his return, he will submit statement in writing for confirming his arrival and again deposit his passport with Nazir of this court immediately. This one time permission is granted subject to furnishing solvent surety in the sum of Rs. 500,000/- with PR bonds in the like amount to the satisfaction of Nazir of this court.

Misc. Application No.32301/16 is disposed of accordingly.
