Muhammad Ali Mazhar, J: The plaintiffs have filed these suits for claiming declaration, recovery of amount, damages and permanent injunction. All the plaintiffs claim to be the government contractor and they were awarded different works order for different projects. Their main grievances are that they have not been paid their dues while in the written statement/reply filed by the defendants a plea is taken that work done is either defective or not completed in accordance with work order.

2. Today, Agha Shahnawaz Babar, Deputy Commissioner, Jacobabad pointed out that in the Sindh Peoples Development Committee's meeting it was decided to form a committee comprising Superintendent Engineer, Works and Services, Jacobabad, Executive Engineer and Assistant Commissioner concerned to verify the physical status of

development schemes which are dropped/discarded but the same deserve to be taken up in the coming financial year 2017-2018 on merits. The Deputy Commissioner, Jacobabad clearly stated that in all these five suits, the Superintendent Engineer along with relevant staff will physically visit the projects along with the contractors or his representatives and they will also measure the work according to the work order. They will also verify the projects physically and financially and after detail examination of each project if any dues are liable or found to be paid to the plaintiffs the same shall be paid to them within four months. However, if it is found that work is not completed or it is defective then it would be the responsibility of the respective plaintiff to complete the work according to the work order and remove the defects if any for making their payments. The learned counsel for the plaintiffs have agreed to this proposal.

3. In view of the aforesaid terms and conditions, the above suits are disposed of by consent along with pending applications.
