Urgent application moved by counsel for the legal heirs of judgment-debtor is granted.

Ms. Sofia Saeed, Advocate for the decree-holder is present. Both legal heirs of the judgment-debtor Mst. Azra Siddiqui & Ms. Ayesha Siddiqui are present with their counsel. Muhammad Aslam Qureshi is present alongwith his counsel Mr. Salman Hamid, Advocate. The Nazir report dated 26.02.2018 is available on record which shows that in compliance of the order dated 03.03.2011, the judgment-debtor through Muhammad Aslam Qureshi deposited two pay orders for Rs.10,00,000/- each on 14.03.2011 and 15.03.2011. The report further reflected that the pay orders were not available despite best efforts to trace. The further report dated 15.03.2018 reflects that the Nazir asked the

banks for issuing fresh pay orders and finally on 26.03.2018 he intimated to the court through his report that fresh pay orders for the same sum have been issued by the banks and cleared/credited into the Nazir's account. The counsel for the decree-holder and legal heirs of the judgment-debtor agreed that the amount encashed by the Nazir may be returned back to Muhammad Aslam Qureshi son of Ghulam Muhammad (CNIC No.42301-0237806-9). Muhammad Aslam Qureshi handed over three original pay orders in the sum of Rs.20,00,000/- to the counsel for decree-holder on behalf of the legal heirs of judgment-debtor. On receiving the original pay orders, the counsel for the decree-holder submits that the decree has been satisfied. The original title documents of the property No.21/A-II, Khayaban-e-Shamsheer, Phase-V, D.H.A., Karachi are stated to be lying with the Nazir of this court. By consent let the original title documents may be released to the legal heirs of the judgment-debtor namely Mst. Azra Siddiqui and Ms. Ayesha Siddiqui on proper verification and identification. The execution application is disposed of accordingly alongwith pending applications.

It is also pertinent to mention that between the same parties Suit No.720/2015 has been decreed today by this court by way of compromise.
