Petitioner Syeda Lubna Haider is present a/w her counsel Mr. Darwesh Mandhan advocate.

Ch. Muhammad Farooq advocate for the NADRA.

Petitioner has approached this court for directions against the NADRA to unblock her CNIC. It is stated that the real father of the petitioner was Syed Bashir Hussain but she was adopted by the Syed Safeer Hussain Kashif since her childhood who was her real uncle. The petitioner was brought up by Syed Safeer Hussain Kashif and in the official record he had shown him as real father of the petitioner. Syed Safeer Hussain Kashif expired on 02.11.2001 and his wife Naseem Akhter in the year 1993, whereas, petitioner's real father Syed Basheer Hussain expired in the year 1985. On 11.08.1984 son of Syed Safeer Hussain Kashif namely Syed Rizwan ul Hassan was born and on some property dispute Syed Rizwan ul Hassan filed a civil suit No. 748/2013 in the court of Civil Judge 1st Class, Islamabad against the petitioner, NADRA office and Federal Government Employees Housing Foundation for declaration and permanent injunction on the ground that Syed Safeer Hussain Kashif was allotted plot No. 40 in Sector G-13/1, Islamabad by the defendant No.3. The bone of contention in that case was that the petitioner was an adopted

daughter, therefore, the directions were sought against the NADRA to delete her name from Form-B of Syed Safeer Hussain Kashif. The suit was decreed on 21.07.2014 and the NADRA was directed to delete the name of Syeda Lubna Haider (petitioner) from Form-B of Syed Safeer Hussain Kashif after fulfilling all codal formalities. The judgment of the Islamabad Civil Court is attached with the statement filed by the petitioner on 21.05.2018. One reply filed in the execution proceedings at Islamabad civil court by the NADRA is also attached in which it is stated that the Syeda Lubna Haider (petitioner) could not show any family linkage with Syed Rizwan ul Hassan in NADRA data base. On showing all these documents, the petitioner in fact wants that in her family record the name of her real father be mentioned as on evaluation of the judgment passed by the civil court, Islamabad and the documents attached it is clear that the NADRA has been directed to remove name of the petitioner from Form-B of Syed Safeer Hussain Kashif. Learned counsel for the NADRA is fully cognizant with the documents and he submits that petitioner may appear before the NADRA Operation Branch, RHO, Mohammad Ali Society, Karachi on 28.05.2018 at 11:00 a.m. along with all relevant documents and certified true copies of the court orders. After considering documents, the record will be rectified and the CNIC of the petitioner will be deblocked. Petition is disposed of accordingly.
