**Muhammad Ali Mazhar.J:** Today Barrister Mustafa Mehaser, Incharge of S.M Law College Karachi has submitted a Statement that all Professors except Fareed A. Dayo, have submitted their answer sheets to the University of Karachi. Mr. Fareed A. Dayo due to some rush of work could not check the copies, however, he requests for four days' time to submit the answer sheets. At the request of Mr. Mehaser as a last chance, four days' time is granted and thereafter he will transmit the answer sheets to the University of Karachi. Dr. Irfan Aziz, Controller of Examination, University of Karachi, submitted a Statement in writing through Deputy Controller of Examination in compliance of order dated 22.05.2018.

Professor Moin Azhar Siddiqui, Principal of Islamia Law College, Karachi and Barrister Mustafa Mehaser, Incharge of S.M Law College, Karachi both have extended their no objection and agreed to the modalities mentioned in the statement for conducting annual examination of law in the month of November / December, 2018. This statement is taken on record with their endorsement.

The Deputy Controller Examination, Karachi University referred us to Annexure R-4 page "9" of the Statement filed on 25.04.2018 and submits that result of LL.B Part I, LL.B Part II, B.A/LL.B (Hons.) III Year, B.A/LL.B (Hons.) IV year and B.A/LLB (Hon) First year will be

announced on 04.06.2018, whereas LL.B Final and B.A. LL.B (Hons.) Final Year will be announced on 10.06.2018 without any fail.

Since the Principal of Islamia Law College and Inchage / SM Law College Karachi both have shown their agreement on the Statement filed in Court today by the Controller of Examination, University of Karachi that all annual examinations of Law will be conducted in the month of November / December, 2018, therefore, the Dean Faculty of Law, who is also Chairman of Board of Studies shall ensure that the statement given by the University of Karachi and the modalities pointed out in the Statement shall be complied with in letter and spirit. However, it is further clarified that the arrangement made through the Statement referred to above is only for all annual examinations of law in the month of November-December 2018 and this undertaking will not prejudice or affect the other examinations which shall be held according to schedule. It is reiterated that the Dean faculty of Law, Controller of Examination Karachi University, Principal S.M. Law College and Islamia College and the Board of Studies shall ensure that the annual examinations of Law shall be conducted within the time line mentioned in the order.

The petition is disposed of along with all pending applications.
