Ms.Fouzia Rasheed holding brief for Mr.Sohail Muzaffar, Advocate submits that the petitioner in C.P.No.D-333 of 2013 has instructed to file an application for withdrawal of this petition, but at present the petitioner has already been represented by Mr.Haider Waheed, Advocate and there is no such application before us.
- 3. The learned counsel for the parties have also referred a decision of Economic Coordination Committee (ECC) of the Cabinet which is available at page-1343 of

the same petition. Since the ECC of the Cabinet has considered the Summary submitted by the Petroleum Division regarding the termination of contract of affreightment (CoA) between PSO and PNSC and decided that the PSO and PNSC should resolve the issue mutually at their own level without referring it back to ECC, therefore, all the learned counsel have agreed that let the matter be decided in terms of the decision of ECC and in case any party feels aggrieved they may institute appropriate proceedings in accordance with law.

4. The aforesaid petitions are disposed of in the above terms along with pending applications.
