4-5. The appellant has challenged the order dated 13.8.2018 passed by learned single Judge in Suit No.1113//2013 .

Learned single Judge concluded the order as under:-

“In the given circumstances, order dated 23.10.2013 is extended to the extent that Nazir shall take over and retain the possession of the suit property and appoint two guards at the cost of the parties and file compliance report within seven [07] days.”

Learned counsel argued that in the impugned order only the interim order dated 23.10.2013 is mentioned but the order dated 25.02.2015 was not taken into consideration when CMA No.9430/2013 moved under Order 39 Rule 1 and 1 CPC was disposed of with the observation that Counsel for defendants/respondents undertook that they will not create any third party interest in terms of interim order dated 23.10.2013 and also that the plaintiff will not be dispossessed during pendency of the suit. In view of the statement made by learned counsel for the defendants, learned single Judge disposed of the application and the interim order passed on 23.10.2013 was confirmed. Learned counsel argued that after confirmation of interim order on 25.2.2015 there was no justification to issue directions to the Nazir to take over and retain the possession of the suit property and appoint two

guards at the costs of the parties and file compliance report within seven [07] days. Point raised requires consideration. Issue notice to the respondents for 30.8.2018. Till next date of hearing the parties are directed to maintain status quo.
