Muhammad Ali Mazhar, J: All the petitioners in the aforesaid petitions have come up with the common prayers that they are entitled to travel to their native place in Bangladesh in terms of Travel Permits issued by Bangladesh High Commission, Karachi. They also sought directions that the Foreigner Registration Officer, Special Branch, Karachi be directed to complete all legal formalities for deporting the Petitioners to Bangladesh. On the last date of hearing, we issued notice to Foreigner Registration Officer, Special Branch, Karachi and Additional Director, Immigration, for the assistance of this Court. Today, both officers are present. In all petitions, petitioners have attached Travel Permits issued by Bangladesh High Commission on different dates but the permissions were valid only three months from the date of issuance. We have noted that some travel permits have been expired for which the counsel for the petitioners categorically stated that the petitioners will approach for renewal of their travel permits for further proceedings. Counsel for the Petitioners is directed to examine each travel permit separately in all petitions and thereafter the petitioners will approach Bangladesh High Commission, Karachi, for the renewal of their Travel Permits. The Special Branch may also approach Bangladesh High Commission for verification of Travel Permits issued to the petitioners.

Since copies of all petitions are already in possession of officers, 2. present in court, therefore, they will also compile list of all petitioners and send the names of all petitioners to the Additional Inspector General, Karachi, who will distribute the list of petitioners to the concerned SSPs (District-Wise) for verification of criminal record of the petitioners if any. The Additional I.G. will direct the concerned SSPs to submit their verification reports within 20 days' time to Foreigner Registration Officer, Special Branch, Karachi directly who after examining all credentials, initiate necessary proceedings for deporting the petitioners from Pakistan to Bangladesh in accordance with law and transmit all necessary documents to Additional Director, Immigration (FIA) for further action at their end. In all petitions, attorney(s) of the petitioners are different so they will be responsible to submit all relevant documents to Foreigner Registration Officer, Special Branch, Karachi for further necessary action in accordance with law.

3. The petitions are disposed of in the above terms.
