**Muhammad Ali Mazhar, J:** Learned counsel for the petitioner submits that by efflux of time these petitions have become infructuous. Mr. Khalid Javed learned counsel appearing for the private respondents submits that all petitions pertain to Federation of Pakistan Chamber of Commerce & Industry (“FPCCI”) elections 2017 and after filing these petitions not only the elections of 2017 have been conducted but the elections of 2018 have also been conducted and the process of holding 2019 elections are under way. He further submits that during pendency of these petitions, there was no interim order against the FPCCI not to hold their elections. Even vide order dated 28.12.2016 the learned Division Bench of this court observed that without prejudice to the case of any of the parties on merits, they were not minded at that time to grant interim orders restraining the elections of FPCCI. In view of this joint statement, petitions are disposed of accordingly.
