**Muhammad Ali Mazhar, J:** The case of the petitioner is that he applied online to appear in Competition Examination (CSS 2018), but failed to submit hard copy of application Form to the Federal Public Service Commission (FPSC). On this objection he filed representation to the FPSC. Since the representation was pending, the petitioner was allowed to appear in the Examination on his own risk as a rejected candidate which fact is also mentioned in the notice issued by Assistant Director (FPSC) to the petitioner copy of which is available at page-35 of the court file. The petitioner has admitted this fact that he did not apply to the FPSC through a hard copy. We have also seen the requirements in the advertisement, published in the newspapers for CSS Competitive Examination, 2018. Under clause 6 of the advertisement procedure for submission of application is given, which speaks that all aspirants may apply online for CSS Competitive Examination from 15<sup>th</sup> October to 14<sup>th</sup> November, 2017 followed by submission of hard copy of online Form along with all attested documents and original Treasury Receipt of Rs.2200/- so as to reach the FPSC, Headquarters, Islamabad within 10 days of the closing date

i.e. on or before 24<sup>th</sup> November, 2017 as per procedure stipulated in Rule-7 of CSS Competitive Examination Rules-2018.

2. In the comments filed by FPSC it is clearly mentioned that total 1019 candidates including petitioner were rejected due to non-submission of hard copy of their online application Form. Out of which 19 candidates including the petitioner submitted representations against their rejection and they were provisionally allowed to appear in the examination at their own risk subject to decision on their representation in accordance with CSS Rules 2018. It is further stated in the comments that the representation were rejected by the FPSC under CSS Rules 2018 and the petitioner was also conveyed the outcome of his representation which was rejected on 9.5.2018.

3. Since the petitioner failed to apply according to the conditions mentioned in the advertisement and it is an admitted fact that he did not submit hard copy of the application Form, therefore, we are of the view that his Form was rightly rejected. No interference can be made out. The petition is dismissed.
