Muhammad Ali Mazhar,J: The petitioners are present in person along with their sons and daughters, whereas the respondent No.3 Mr.Salman Khan, Advocate, who is also son of the petitioners and real brother of other persons named above is present.

2. The grievance of the petitioners is that the respondent No.3 has filed some fabricated applications against the petitioners and other family members to different forums. It was prayed that the respondent Nos.6 to 8 may be directed not to take any action against false

application without any proof against the petitioners and other family members.

3. Mr.Salman Khan, who is also an Advocate (Respondent No.3) categorically stated that he never filed any application against the petitioners or his real brothers and sisters and denied all such allegations recorded in the petition against him.

4. In the first round of hearing, after arguing at some length parties attempted to resolve the dispute amicably and in the second round the respondent No.3 has given clear assurance and statement that he respects the petitioners who are his real parents as well as brothers and sisters and he also apologize to his parents which was accepted by them and he has settled the matter amicably with his family members in court.

5. The petitioners and their family members as well as Respondent No.3 (Salman Khan) undertake before this court that they will not circulate any disparaging or defamatory material against each other on social media nor file any complaint against each other without just cause. The police officials present in court stated that they will not cause any harassment or threat to the petitioners and their family members and they shall strictly act in accordance with law.

6. In view of above, this petition along with pending application is disposed of accordingly.
