None present for respondent Nos.4, 7 and 10. Repeat notices to them through their Directors/Medical Superintendents to ensure the presence of their representatives on the next date of hearing. Mr. Riaz Gill, Assistant Director, Jinnah Postgraduate Medical Centre (JPMC) and Dr. Abdul Saeed, Deputy Medical Superintendent (Court Matters), Civil Hospital, Karachi are present and they also request for time to submit their reply, however, they have clearly stated that their emergency services and Out Patient Department (OPD) are opened, whereas this assertion was contested by the learned counsel for the petitioners. Let specific replies be filed on this point. By consent adjourned to 19.05.2020. In the meanwhile, the respondent Nos.3 to 10 shall continue their OPDs, first aid and emergency services in the larger public interest.
