Muhammad Ali Mazhar, J: Basically, the pith and substance
of both the petitions are to seek directions against the
respondents for announcement of date of holding L.L.B. Final
year examinations, as according to them these examinations

were to be held in the months of June or July in 2019, but the same have been delayed.

2. The representative of Karachi University and their counsel submit that the delay was caused due to Covid-19 pandemic situation and the Government of Sindh has also issued lock down orders from time to time in which it was not possible for them to conduct the examinations during lock down period. They further submit that they have come to know that the universities will be opened from 15.09.2020, but there is no final date for opening of universities. The same statement has been given by Mr.Moin Azhar Siddiqui, Learned Principal, Government Islamia Law College, however, the representative of Karachi University has filed a statement duly signed by the Controller of Examination, University of Karachi dated 12.08.2020 in which they have shown their willingness for holding examination in due course, however, it is further submitted in the last paragraph that schedule of examination will be announced in the first week of October, 2020, subject to opening of universities under the directions of the Sindh Government. The proposal is accepted by the petitioners, however they request that no further delay should be caused for holding examinations.

3. Both petitions are disposed of with the directions to the Karachi University to announce the schedule of examination of L.L.B. Final within 15 days from the date of opening of universities and examination will be conducted according to

said schedule and the result will be announced within 90 days as per rules as agreed by the representative of Karachi University.
