The Respondent No.1 was granted post arrest bail by this court vide order dated 02.04.2020 in Criminal Bail Application Nos.22, 23, 24 and 25 of 2020 (FIR Nos.27, 28, 29 and 33/2013 lodged under Sections 409, 420, 468, 471, 109, PPC and read with Section 5(2) PCA-II, 1947, P.S. FIA Crime Circle Karachi).

- 2. The bail was granted subject to furnishing surety of Rs.100,000/- with P.R. Bond in the like amount to the satisfaction of the trial court. The respondent No.1 was also directed to submit a pay order in the sum of Rs.11,00,000/- from his Bank Account, which is being operated by him in the NBP and the same shall be deposited in the trial court. Before complying with this condition the NBP filed aforesaid Criminal Misc. Applications and prayed for cancellation of bail.
- 3. Today Mr.Adnan Nazir, V.P. Regional Office, South Karachi, National Bank of Pakistan has filed common statement

but separately in each Criminal Misc. Application, which is reproduced as under:-

"It is mostly humbly and respectfully prayed on behalf of the applicant above named that this Hon'ble Court may be pleased to pass the order and allow the application (NBP) to withdraw the titled Cr. Misc. Application because the National Bank of Pakistan (NBP) is ready to comply with the order dated 02-04-2020 and will issue the Pay Order for Rs.1,100,000/- in favor of TDAP from the account of End Service benefits of the accused. Hence the titled Cr. Misc. Application has become infructuous."

Copy of the above statement has also been supplied to I.O. as well as Assistant Attorney General, who have gone through the same and they have no objection if the aforesaid criminal misc. applications are disposed of accordingly.

4. Learned counsel for NBP undertakes to deposit pay order in the sum of Rs.11,00,000/- in favour of TDAP in the learned trial court within 10 days from the account of respondent No.1. The same will be handed over by the learned trial court to the TDAP in view of bail order dated 02.04.2020.
