
All these petitions have been filed by petitioners seeking appointment on different posts on deceased quota in the Education Department of Government of Sindh. After making their respective submissions at considerable length, learned counsel for all the petitioners in these petitions, representatives of the Education Department and learned A.A.G. have agreed that all these petitions may be disposed of in the following terms :


- I. Petitioners shall submit their respective applications along with supporting material / documents to the Secretary, Education Department, Government of Sindh, through any recognized courier service on or before **15.11.2019**, whereafter the said Secretary shall forward their applications to the relevant department / authority for scrutiny and consideration.

- II. Cases of all the petitioners shall be considered and decided by the District Recruitment Committee (DRC) through a speaking order on or before **31.01.2020** strictly in accordance with law and the prescribed rules, procedure and policy, and after providing opportunity of hearing to the petitioners.
- III. Offer letters shall be issued only to those petitioners who are approved by DRC / competent authority whereafter such petitioners shall complete all legal and codal formalities required under the law and the relevant rule, procedure and policy.
- IV. Petitioners who are not approved by the DRC / competent authority may seek their remedy, if any, before the competent forum in accordance with law.
- V. Compliance report in the above terms shall be filed by the Secretary, Education Department, Government of Sindh, through learned A.A.G. with the Additional Registrar of this Court latest by **15.02.2020**.

Let notice be issued to the Chief Secretary Sindh and Secretary, Education Department, Government of Sindh, along with a copy of this order for its compliance in letter and spirit.

By consent, all these petitions are disposed of in the above terms with no order as to costs.
