Muhammad Ali Mazhar, J: The petitioner through attorney on 17.04.2019 argued that after one time verification of the owner, no further verification is required on annually or periodically basis. To ventilate the grievance, the learned counsel for the respondent No. 1 to 3 filed statement on 10.06.2019 which is reproduced as under:-

“Statement

I, Muhammad Asif Malik, Advocate, practicing at Karachi, do hereby state that I am duly engaged counsel for the Respondents No. 1, 2 & 3 as such state under the instructions that present petition pertains to Issuance of Entry Pass of Mst Nazia, a maid servant of petitioner as such the petitioner is not required to submit police verification and field staff verification of herself, however, the police verification of the said maid servant of Mst Nazia is required as per the prevailing policy.

It is further stated that the petitioner may file application in respect of her maid servant (as already depicted at page No. 27 of the petition) and her case shall be processed accordingly, till the completion of verification process, she will be issued with a

temporary receipt on the basis of which she can enter into Malir Cantt for her job.

It is humbly clarified that no police verification of the owner (petitioner) is required for renewal/issuance of Security Pass of the maid servant Mst Nazia as no case for renewal/issuance of entry pass in respect of petitioner is pending before the answering respondents.

It is clearly stated in the statement that the petitioner is not required to submit police verification and field staff verification, however, police verification of the maid is required as per prevailing policy. Let the petitioner apply for the entry card/pass of their maid/servants and after verifying the antecedents as per prevailing policy, the necessary security pass/entry pass will be issued to the servant within a period of one (01) month and till issuance of security pass, the maid shall be issued temporary receipt to enter into Malir Cantt as stated by the counsel in his aforesaid statement. Petition is disposed of accordingly along with pending applications. The order may be complied with within one (01) month. Copy of this order may be transmitted to the respondents No.1 and 2 for compliance.
