Alleged detainue Shrimati Jami has been produced from Darul Aman by ASIP Muhammad Alam.

The background of the case is that Applicant Dhano (father of alleged detainue Shrimati Jami) has filed instant criminal miscellaneous application for production of said Shrimati Jami before this Court and recording her statement, as at that time it was alleged that Shrimati Jami was residing with Respondent No.4 (Raju). It appears from record that on Court notice, Shrimati Jami (alleged detainue) was produced before the Court on 08.10.2018 by ASI Chain Singh of Police Station Samaro, when after hearing both parties, this Court has sent Shrimati Jami to Darul Aman with direction to the Incharge Darul Aman to produce her before the Court on next date viz 22.10.2018. On being seen various Court diaries with the able assistance of parties' counsel, I found that there are wavering statements of Shrimati Jami with regard to joining her father or Raju (Respondent No.4). Vide order dated 21.10.2019, this Court observed that Raju is a stranger man (not Maharram) to Shrimati Jami, therefore, her request to join Raju was declined. Today, alleged detainue has been again produced before the Court by Superintendent, Darul Aman. She has been heard at length in open Court. She submits that she is *sui juris* and at the moment she wants to join her father Dhano (Applicant) and mother Shrimati Heera, who are present in Court. She has also filed an application through Director, Social Welfare, Darul Aman, Hyderabad dated 22.10.2019,

which is available on record, requesting therein to release her from Darul Aman and allow her to join her father Dhano so that she may be able to make further decision with regard to her future life.

In view of the statement of alleged detainee Shrimati Jami in Court today and as already observed and in view of the application made by her through letter dated 22.10.2019 sent by the Director, Social Welfare, Darul Aman, Hyderabad, since Dhano (Applicant) and Shrimati Heera present in Court, are real father and mother of the alleged detainee, therefore, she is set at liberty to go with them. Let Shrimati Jami be sent back to Darul Aman with direction to Incharge / Director, Social Welfare, Darul Aman, Hyderabad to release her from Darul Aman and hand over her custody to her parents (Dhano and Shrimati Heer) after due verification, identification and obtaining valid receipt. SSP Umerkot and SHO P.S Samaro are directed to provide protection to alleged detainee Shrimati Jami as and when needed, however, in accordance with law.

This criminal miscellaneous application stands disposed of in above terms alongwith the pending application(s), if any.
