It appears from the record that accused Rizwan Ali was granted interim pre-arrest bail by this court on 23.02.2018, subject to his furnishing solvent surety in the sum of Rs.2,00,000/- (Rupees two hundred thousand only) and P.R. Bond in the like amount to the satisfaction of Additional Registrar of this court. On perusal of case file, it further appears that interim pre-arrest bail in favour of accused Rizwan Ali was dismissed for non-prosecution on 15.02.2019. Now the learned IVth Additional Sessions Judge/Model Criminal Trial Court-II, Hyderabad has made a reference which is taken on record, showing that the said accused has jumped the bail and absconded away.

Conduct of the accused Rizwan Ali appears to be against the law and he has taken law into his own hands. Under these circumstances, office is directed to immediately send the surety papers already submitted by surety before this court to the trial court viz. IVth Additional Sessions Judge/Model Criminal Trial Court-II, Hyderabad for initiating necessary action against the surety as per law.
