counsel for Ranipur Sugar Mills Ltd. have agreed to a modality that the parties may be directed to appear before the Cane Commissioner who is also present in court and will submit their record for the proper reconciliation as the competent authority who will decide the matter is the Cane Commissioner. Mr. Ijaz Ahmed Zahid, learned counsel appearing for Ranipur Sugar Mills Ltd. in C.P. Nos.D-3329 and 3330 of 2019 undertakes to file vakalatnama for Ranipur Sugar Mills Ltd. also in C.P. No.D-7480 of 2019 in the office. Let the parties appear before the Cane Commissioner and file all their relevant documents/claims and the Cane Commissioner after providing ample opportunity of hearing will decide the claims and communicate the same to the Ranipur Sugar Mills Ltd. if they are found liable to make some payments. The entire exercise should be completed within 45 working days. The petitions are disposed of accordingly.
