Through the instant petition, Petitioner, Mst. Seema Anvery has prayed for the grant of Succession Certificate and Letter of Administration moveable in respect of and immoveable properties/assets, details whereof are mentioned in the Schedule of Properties attached with the memo of petition, available at page 23, which were left by her deceased husband, namely, Syed Mohsin Ali Anvery s/o. Syed Asad Ali Anvery, who allegedly died on 10.12.2012 at Karachi, leaving behind (1) Mst. Seema Anvery (widow/petitioner), (2) Mst. Mehar Zaidi (daughter), (3) Syed Khalid Ali Anvery (son), (4) Mst. Saba Anvery (daughter) and (5) Mst. Samar Asim (daughter) as his legal heirs. Original Death Certificate of deceased as well as photostat copies of Family Registration Certificate, issued by the NADRA, title documents of the immovable properties and dividend warrant of shares are also filed at page 19, 21 and 33 to 57.

Legal heirs No. 2 has filed affidavits of no objection for the grant of Succession Certificate and Letter of Administration in favour of the petitioner for herself as well as on behalf of legal heirs No. 3 to 5, being their Attorney, who have executed Special Power of Attorney, duly attested by the Notary Public at Karachi and Head of Chancery in the Consulate General of Pakistan at Los Angles, USA in her favour.

Two witnesses, namely, Syed Zafar Zaidi s/o. Syed Hassan Manzoor and Adnan Zaidi s/o. Syed Zafar Zaidi have also filed their respective affidavits and affirmed that there is no other legal heir of the deceased except mentioned above. Their affidavits are also available on record.

Notice of this petition was published in Daily "Jang" Karachi, Lahore and Quetta dated 27.06.2019; however, none has filed any objection to the grant of Succession Certificate and Letter of Administration to petitioner, as per the report submitted by the Deputy Registrar (OS) on 22.08.2019.

Today petitioner and legal heir No. 2 as well as above named witnesses are present. They affirm the contents of memo of petition as well as their affidavits and also verify their signatures thereon.

Since all the legal formalities/requirements have been fulfilled, there is no impediment in grant of Succession Certificate and Letter of Administration to petitioner, therefore, the petition is allowed. The office is directed to issue Succession Certificate and Letter of Administration in respect of movable and immovable properties/assets shown in the Schedule of Properties, as per rules.
