"STATEMENT

Undersigned states that approval dated: 03.01.2020 was issued by the then Incharge/Deputy Director Technical ROH which

possesses condition at serial No.ii that proponent shall approach to Ministry of Climate Change (MOCC) for seeking permission regarding import of scrap tyres.

That SEPA made binding on proponent for seeking permission from Ministry of Climate Change in respect of import of scrap tyres before implementation of Import Policy Ordinance, 2020. Subsequently, Import Policy Ordinance, 2020 was issued on 25th September 2020 which orders at Serial No.9 that **petitioner is allowed to import scrap tyres.**

That approval dated **23.10.2020** was issued to M/s. Hi-Tech Recycling & Engineering Industries after implementation of Import Policy Ordinance, 2020. This approval was issued without any condition for seeking permission from the Ministry of Climate Change.

It is therefore submitted that petitioner may please be directed to submit application for seeking fresh Environmental approval, the same will be considered and issued accordingly. Hence, this submission.
